



FEE POLICY 2026/27

Updated May 2026

DISCOUNTS

- 3% annual payment discount where tuition fees for the academic year are paid in full prior to Monday 17th August 2026.
- Sibling discounts may be offered where three or more children from the same family attend school with 5% sibling discount for 3rd child, 10% for 4th and more.

REGISTRATION AND ADMISSION FEES

Notwithstanding the conditions mentioned in the parent-school contract, the registration and admission fees are regulated as follows:

525 AED non-refundable application fee (inclusive of 5% VAT)

NEW STUDENTS

We will charge 5000AED as an admission deposit to confirm that selected students will opt to take up the offered places. This fee should be deducted from the total tuition fees for the academic year in which the admission is being sought and therefore is non-transferable. This deposit is non-refundable unless notified at least 60 calendar days prior to the school start date. If new students enrol at a school during the course of the academic year, the school can change tuition fees starting from the month of enrolment. (For example, if a student enrolls in a new school in the 3rd week of October, the school can charge tuition fees from the beginning of October).

EXISTING STUDENTS

5% of the school's tuition fees as a re-registration deposit to confirm the return of existing students in the new academic year. This deposit will be deducted from the first term tuition fees for the academic year in which the admission is being sought. This deposit is non-refundable unless notified at least 60 calendar days prior to the school start date.

The deadline for paying the re-registration deposit is 1st May 2026. If the re-registration deposit is not paid by the above deadline, the school will not guarantee the child's place for following academic year.

Please be advised that the re-registration deposit does not guarantee a place with the school unless all outstanding fees owed by you to the school for the past academic years have been fully settled. The school reserves the right to deduct and offset the outstanding fees with the deposit which you have paid.

REFUND

In the cases of both existing and new students, deposits and fees will not be refunded if students choose not to return to school for the next academic year or choose not to take the offered places unless notified at least 60 calendar days prior to the school start date.

In the case of refund and recovery, the school fees will be calculated as follows:

- If the student was enrolled in the term for two weeks or less: a month's fees will be deducted.
- If the student was enrolled in the term for a period between two weeks and one month: two months fees will be deducted.
- If the student was enrolled in the term for more than one month: the full term's fees will be deducted.

Charges for books and school uniforms will not be refunded.



WITHDRAWAL

If you wish to withdraw your child from school, a withdrawal/leaver form must be completed specifying the intended withdrawal date.

The same intended withdrawal date is the official date from which all refund calculations are made.

The refund date is not determined by the date the student was last physically present or last class attended.

The school is entitled to withhold the Withdrawal/Transfer Certificate until all outstanding fees have been paid in full.

The Withdrawal/Transfer Certificate is required for a student to register at any other private school or educational institution in Dubai and across the UAE.

Important: A student's absence from school does not constitute withdrawal or trigger a refund. Being listed on the school's registrar is considered active enrolment, regardless of attendance. Parents must complete and submit a withdrawal request at the earliest opportunity to avoid additional fee liability.
